## **VEEP SPEAKS**

This record-setting drought year has not been good for viewing native plants in the field, but could be very good for native plants in the garden. With less snowmelt in the Sierra Nevada and less water in the Colorado River, the cachet of “water-wise” plants is sure to rise. California natives are, of course, specifically adapted for our conditions and are the logical choice of any enlightened gardener.

The general public is unaware of the difference between a native cactus and an African euphorb, however, and the horticultural trade has not been quick to educate them. Just as arundo, tamarisk, and their ilk have overrun our native riparian communities in the last century, drought-adapted exotics could be the scourge of upland habitats in the 21st. Without native parasites and predators (a plus in the nursery trade) a few generations of selection could turn today’s benign specimen plants into invaders with a competitive advantage over beleaguered natives. As Carl Bell explained at our last meeting, most invasive plants were deliberately introduced. Our children may look back in disbelief at our folly in introducing a new horde of xerophytic pests, just as we look back in disbelief at planting of ice plant for erosion control and eucalyptus for railroad ties.

Each native plant garden is not only an example of a more rational way to live within our hydrological means, but an opportunity to show off the beauty, diversity, and habitat value of our local species. I encourage our native gardeners to take advantage of the great advertising literally in their own back yards and spread the word about the benefits of using natives both today and for the future.

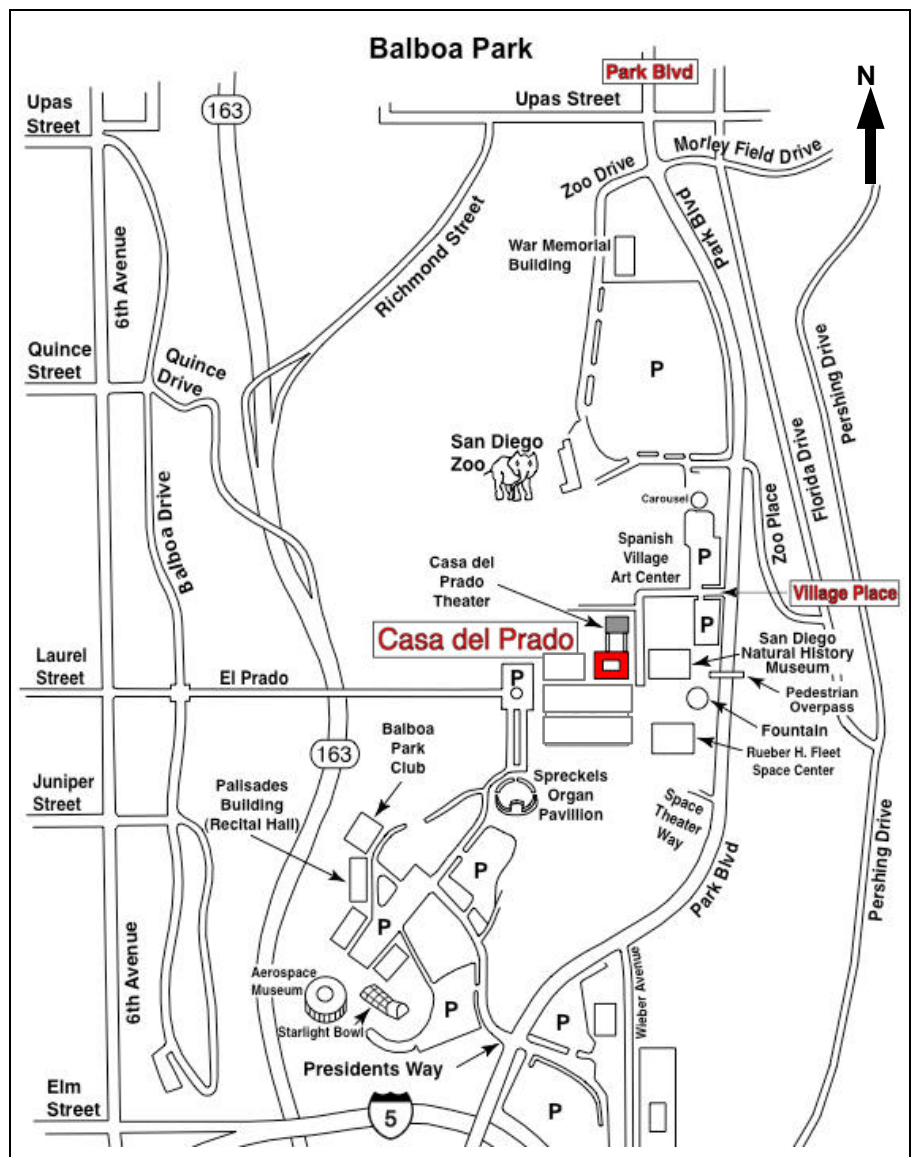

## CHAPTER POSITIONS

As many of you know we cannot just expect conservation to happen on its own free will. It would be nice if everyone just followed all the rules and regulations and surveyed and accurately reported all threatened and endangered plants that occurred on their property. As volunteers, this is one of our most important responsibilities, to be involved in protecting our natural resources. The conservation committee reviews development projects throughout San Diego County to ensure that environmental rules and regulations concerning native plant habitats are followed. We have a team of volunteers that works to review environmental documents (such as EIRs and EISs), write comment letters, attend public hearings, or meet with public officials and resource managers. We are in the process of designating a bi-monthly meeting schedule. Committee meetings would be held on a week night evening and the location could rotate around the county. Committee members would have responsibilities to fulfill such as reviewing environmental documents, conducting surveys, or attending public hearings.

**Conservation Committee members:** The Committee needs a number of additional members to help with this long list of tasks and activities.

**Monthly Program Assistant:** Carrie Schneider currently coordinates our monthly programs and is looking for a volunteer to help out. Duties include arranging for the monthly presentation and helping to set-up the projector.

**Public Outreach Chair:** The primary responsibility is to coordinate our display and outreach materials for environmental fairs and other public events.

## **WATER CONSERVATION SUMMIT**

Companies and professionals who design, develop, maintain and manage San Diego County's urban landscape are invited to the second annual Water Conservation Summit, Oct. 12, at the University of San Diego's Joan Kroc Institute.

The goal of the Summit is to develop a long-range water conservation plan for saving 108,000 acre-feet of water annually in San Diego County by 2030.

The 2006 Summit introduced over 240 professionals to a market-based strategy to develop water-efficient landscaping in San Diego County, and launched three public/private workgroups to design a model water-efficient landscaping ordinance, a collaborative industry cluster, and public education.

The 2007 Summit will report and review the progress of the workgroups and discuss two additional strategies: water recycling and a working partnership between the water and energy industries. Three presentations in the morning will be followed by lunch and four more interactive sessions..

## RAPID ASSESSMENT

Please join the CNPS Vegetation Committee for our rapid assessment survey on Saturday, Sept 22 starting at 9:00 a.m. Thanks to Patrick O'Connell and the other folks at the Center for Natural Lands Management (CNLM) for setting up this month's location.

What: We use the Rapid Assessment protocol to collect scientific data about plant communities throughout the San Diego area so we can better understand them. Habitats that house rare plants or wildlife are also often targeted to better understand why these species are found where they are and aid in their conservation.

Why: The Rapid Assessment protocol is a relatively quick way to collect detailed information about large areas of vegetation. Our data may help in monitoring of conservation efforts and/or future restoration efforts. Also, our studies contribute to the CNPS statewide database, which is used to update the Manual for California Vegetation.

Cost: Regular survey events are free and open to the public (although CNPS membership is encouraged!) Additional donations are always welcome. Light snacks and beverages are provided for volunteers.

## STINKWORT REVEALED

### *Dittrichia graveolens* (Stinkwort)

For those of you who would like to see what *Dittrichia graveolens* looks like, the drainage behind Carroll Canyon Business Park is an easy place to access to see the plant. Mike Kelly had been to look at the Willowy monardella transplants that were a requirement of the development of the business park and reported on both the *Monardella* and the *Dittrichia* to me. Go to the western end of Carroll Canyon Road off Camino Ruiz and follow the path around to the drainage side of the business complex. The Stinkwort is about 150 feet in. If you follow the path around to the east it will take you to a dirt road that runs down into the drainage. In early August some of the plants were just starting to bloom with their small yellow flowers. Stinkwort is in the Asteraceae. If you go to the area, please make sure you are seed free when you exit the area.

*Dittrichia* has an oil that caused a skin reaction in both Mike and I so I recommend not touching the plant bare handed. It appears to grow in open sunny disturbed areas mostly in drainages, although the plant can grow in non-drainage areas. Petropoulou, Alexandra, Tzakou, Olga, Verykokidou, and Eumorphia looked at the volatile chemical components of the plants by gas chromatography analysis and found epi-a-cadinol (30.2%) and bornyl acetate (25.4%) to be the most common components of the oil in plants from Greece. Others have looked at the oil components in plants from Iran previously.

I had hoped the management associated with MSCP would deal with issues like this but it is not structured to manage lands very well. The Weed Management Area in San Diego is also not structured so that it can jump on early infestations of weeds. As far as I know, Carroll Canyon is the only existing population of the species in San Diego (I could be very wrong here though). Would someone like to coordinate with the various sand and gravel mining entities and other land owners to see if they can eradicate the species in the drainage?

## NOAA GRANT PROGRAMS

NOAA's Office of Habitat Conservation has released information about the following four funding opportunities for FY 08:

Community-based Habitat Restoration Project Grants: FFO# NMFS-HCPO-2008-2001032. The NOAA Community-based Restoration Program (CRP) provides funding and technical expertise to implement locally-driven, grass-roots habitat restoration projects. The NOAA Restoration Center (RC) anticipates that typical awards will range from \$50,000 to \$200,000.

Community-based Marine Debris Prevention and Removal Project Grants: FFO# NMFS-HCPO-2008-2001026. The NOAA Marine Debris Program (MDP), authorized in the Marine Debris Reduction, Prevention, and Reduction Act (33 U.S.C. 1951 et seq.), provides funding to implement locally driven, community-based marine debris prevention and removal projects. Awards - \$15,000 - \$250,000. Applications due October 31, 2007

Open Rivers Initiative: FFO# NMFS-HCPO-2008-200103: The NOAA Open Rivers Initiative (ORI) provides funding for locally-driven projects to remove dams and other barriers. Awards will range from \$50,000 to \$250,000. Although a select few may fall outside of this range, project proposals requesting less than \$30,000 or greater than \$1,000,000 will not be accepted or reviewed. Applications due October 31, 2007

## RIVER PARKWAY GRANTS

Proposition 50 California River Parkways  
Grant Program Revised Guidelines & Application Deadline

The Resources Agency has released revised California River Parkway guidelines for the 2007-08 grant cycle. CSG is currently reviewing the new guidelines and will send an update identifying any major changes to the program.

The Resources Agency is pleased to announce the release of the Guidelines and Application for the Proposition 50 California River Parkways Grant Program third round of funding. The California River Parkways Grant Program is a competitive grant program for river parkways projects. Eligible projects must meet a minimum of two out of five statutory conditions and provide public access or be a component of a larger parkway plan that provides public access. \$20.5 million for the third round of grant awards is included in the proposed 2007/08 Governor's Budget.
