The introduction of some nursery grown native plant material into the local ecosystem has recently received significant attention from industry experts. Many believe that nursery grown plant materials can actually disrupt and damage the gene pool of local species.

This month the San Diego CNPS will host two experts on this subject in a forum moderated by a volunteer CNPS board member.

Mike Evans, co-founder of Tree of Life Nursery and **Jonathan Dunn** former Manager of the CRES Seed Bank will share their perspectives on the risks and the benefits of nursery grown materials. Please join us for this important and relevant discussion.

VOLUNTEER OPPORTUNITIES

LIBRARIAN: CNPS has a small library that is available to CNPS members during our meetings. We need someone to oversee the library and check out books to members. SALES TABLE: At our monthly meetings and plant sale we sell books to raise money for our chapter. We always need help at our sales table. CONSERVATION: We review development projects throughout San Diego County to ensure that environmental rules and regulations concerning native plant habitats are followed. VEGETATION SURVEYS: Anyone who would like to help survey is welcome to attend; the only prerequisites are an interest in preserving native habitat, attention to detail, and a patient attitude, as the surveys are quite detailed. If you have not done Rapid Assessment before, training will be provided on-site. You will be able to work with more experienced surveyors to see how the survey is done. TOLL ROAD HEARING

Biologist Fred Roberts and I represented CNPS San Diego at the US Dept of Commerce hearing in Del Mar Sept 22. The hearing invited people to speak on whether or not to build a toll road through San Onofre State Park. Over a thousand people came, with those opposed to the road dominating at least 4:1, based on my estimate of the ratio of free tee shirts worn by the opposing sides.

Fred drafted the facts on risks to various species found in San Onofre State Park. The Park would effectively be destroyed if the toll road were built there, since it would build on 1/3 of the site and split the other remnants in half. Our presentation noted threats to a large healthy population of thread-leaf

Brodiaea; the valuable habitat there for one of only four populations of the critically endangered Pacific Pocket Mouse; and California gnatcatcher habitat, which is especially precious since the October fires consumed a large area of occupied habitat so the birds are concentrated in the Park land now, land that would be destroyed.

Other opponents included Audubon Society groups, Dan Silver for Endangered Species, League of Conservation Voters, State Parks Foundation, a whole array of camping, outdoor education, and surfing clubs, and a biologist from the San Diego Zoo, to name a few. I thought the most delightful were a child of about 8 who said he spoke for the future generation, and a lady probably in her '90's who had helped found the State Park. The hearing started at 10:30 and ran til 8:30, with several ten minute breaks. Over 650 people had asked to speak, but our number 121 came up after 6:00 PM, so most people did not have an opportunity to voice their point of view.

Whatever happens with the toll road, I want to plan a field trip for San Diego CNPS members to meet up with OC CNPS members in the spring to explore the Donna O'Neill preserve. We would either be celebrating another year of protecting this 1200 acre natural treasure for the future, or will be seeing it perhaps for the last time, if this federal agency is authorized to overturn the State of California's Coastal Commission

1400 FREE TREES - NOV 8

Bill Nelson, of Pacific Tree farms will be giving approximately 1400 Native Trees to fire victims. The trees are two years old and are one to two feet tall in ten inch tubes. The trees have been acclimatizing to the mountain at Art Cole's home in Wynola at 3800 ft.

The seeds were obtained locally from native germ lines. The varieties are Jeffrey Pine, Ponderosa Pine, Coulter Pine, Incense Cedar, and Cuyamaca Cypress.

Bill will be offering 1 to 5 trees per acre up to thirty total to any fire victim who will make a good home for them. You can contact Bill at: (619) 422-8887.

The trees will be distributed from 8am to 1pm on Saturday, Nov 8 at the Julian Public Library. Art Cole will be delivering the trees to the Julian Library and can be reached at (760) 765-1771.

continue up to Julian

go right at stop in Julian

proceed 3/4 mile

The library will be on your left after the Post Office. The building is Forest Green with White Sage trim.

The museum's Canyoneers interpret natural history by leading free, public weekend hikes in San Diego, Riverside and Imperial Counties. These may be Friday hikes with small groups of school children or weekend hikes with the general public.

PLANT ATLAS GOES PUBLIC

In the interest of disseminating as much data as possible to the public, and the fact that the San Diego County Plant Atlas project has exceeded 35,000 collections, Dr. Jon Rebman, Curator of Botany, has directed that all of the data be opened to the public.

The web site, www.sdplantatlas.org, has been reworked to open database searching and mapping to all users without the requirement for passwords. Public users can now view the complete synoptic collection of 2,475 plant specimen images.

Database searching and mapping include the complete Herbarium San Diego collection as well as the Plant Atlas, a total of over 70,000 specimens. Note that the older San Diego County specimens (pre-Plant Atlas) have now been fully databased and georeferenced to allow mapping of the entire collection.

All the web pages related to the functions of the Parabotanists have been isolated. Parabotanists are still required to have a unique password to enter data and edit their data.

LEGISLATE BEFORE THE FIRES

JONES LEGISLATION REQUIRES THAT FIREFIGHTING SERVICES EXIST BEFORE APPROVING SUBDIVISIONS IN HIGH RISK FIRE AREAS

The California State Legislature passed legislation authored by Assemblymember Dave Jones (D-Sacramento) that will require that before counties approve new subdivisions in high fire hazard areas, they certify that adequate fire protection will exist.

"I have listened to the pleas of fire officials who have repeatedly pointed to the growing risk involved with building in fire-prone areas," said Jones. "My bill requires a sensible approach to approval of new building sites in high fire danger areas. This legislation will save both homes and lives."

While California has made strides in getting in place stricter building and defensible space standards to help avoid even worse loss of property, Jones' AB 2447 addresses the planning or prevention side of the issue. It allows a county to approve a new subdivision in a high fire risk area only if they find that they meet Cal Fire's subdivision design standards, they certify that the fire fighting agencies can provide structural fire protection for the parcels that would be created, and the subdivision has more than one way in and out to serve it. Assemblymember Jones said, "We cannot continue to approve new subdivisions in the most hazardous areas if there is not adequate fire protection. AB 2447 will help us avoid putting the lives of firefighters, and the lives and property of homeowners, and the dollars of taxpayers, needlessly at risk."

AB 2447 is supported by firefighters, environmental groups and property owner groups. The Assembly took final action on the measure on August 30th, by concurring with amendments made in the State Senate. The bill now moves to Governor Schwarzenegger.
